## What is the ALS?

In the first half of 2006, the 6 Aboriginal and Torres Strait Islander Legal Services (or "ATSILSs") servicing New South Wales (NSW) and the Australian Capital Territory (ACT) agreed to come together to form one NSW- and ACT-wide legal service. Those 6 ATSILS were the Sydney Regional Aboriginal Corporation Legal Service, the Kamilaroi Aboriginal Legal Service, the Many Rivers Aboriginal Legal Service, the South Eastern Aboriginal Legal Service, the Western Aboriginal Legal Service and the Wiradjuri (Central Southern) Aboriginal Legal Service.

The legal service they created is the current Aboriginal Legal Service (NSW/ACT) Limited -or more simply, the ALS. The ALS commenced operations on 1 July 2006.
